Good afternoon Ms. Rouse,

It was nice speaking with you the other day. While my client appreciated your willingness to make an offer, it unfortunately rejected the \$500. As I mentioned in my January 18th email, the cost of our client's license for one year is \$11,988. For nine years of use, the cost of the license would have been \$107,892. To be candid, jurisdictions are split on whether they want to limit lookback for damages. Some jurisdictions only will consider three years of damages – which would make my clients lost license \$35,964. With those numbers in mind, the \$500 offer was just not made in good faith.

Based on your January 16th email, my response to it, and the offer you subsequently made, I feel that it would be more expeditious to provide to you our client's bottom number, as opposed to going back and forth. I know you want to resolve this expeditiously, of which I am trying to be respectful of. With all this in mind, I was able to get my client to lower it's offer to \$11,988 – the cost of one year's license. They have indicated that if you reject this offer – which is your

prerogative – then they would like us to get a lawsuit filed. I will respect whatever decision you make, but I wanted to be transparent with you. Please let me know how you would like us to proceed. I look forward to hearing from you.

Thank you for your response to our communications. In an effort to respond to each of your points, I will number accordingly.

1. Ms. Rouse, our communications to your office are simply following up on the matter in attempts to speak with you directly – no harassment. Now that I have a direct line, and per your request, I will keep to contacting you directly.

2. The significance of 2013 as the year in which the infringement occurred is in the way my client can pursue the matter. Pre-Registration infringements limit our client to elect actual damages rather than statutory damages and any mulitpliers statutory damages incur.

3. Statute of Limitations is three years from the discovery of the infringement – not three years from when the infringement began. Our client sent an initial infringement notice on the date of discovery: August 12, 2022. Thus, the statute of limitations for this case is August 12, 2025. Attached is a copy of the initial infringement

notice.

4. Actual damages are the cost of lost licenses and a disgorgement of Defendant's profits. Our client makes its library available for \$999.00 per month (https://preparedfoodphotos.com/featured-subscriptions/) with a minimum subscription of twelve (12) months https://preparedfoodphotos.com/terms.of.use.php. Thus, irrespective of how long you utilized the subject photograph, the *minimum* license fee that would have been owed is \$11,988.00 (\$999.00 x 12 months).

Mr. Rodriguez,

In response to an email sent December 12th, 2022 and after consulting with legal professionals I offer the following.

- 1. I am requesting that you immediately cease contacting my employees or my office; you have been harassing my employees during their hours of work. If you need to communicate further please send all correspondence to me at Arcadia Academy, 211 South College St., Arcadia, MO 63621.
- 2. My business's alleged use of the single photograph was in 2013 according to the photo you sent. However, it appears that your client's license business did not begin until 2016, three years after the alleged use. You have shown no evidence that the photo was available for licensing at the time of use. If you have evidence showing license availability from 2013, please send it to me immediately.
- 3. The time period for filing a copyright infringement claim is three years after the alleged infringement, which means the time period for bringing a claim expired in 2016.
- 4. You have presented no evidence of actual damages to your client, nor have you presented evidence that a Facebook post is a "commercial use" of the photo.

5. At no point after your clients alleged copy right of the aforementioned photo in 2016 did any one contact Arcadia Academy regarding the new copy right until your contact on December 12th, 2022, at which point you acknowledged in your correspondence that picture had already been removed. Unless you provide evidence as noted above, if you continue to pursue this matter, I will report you to the State Bar of Florida as engaging in misconduct by misrepresenting both the facts and the copyright laws regarding this matter.
